CONDITIONS OF PARTICIPATION IN THE CONFERENCE

It is obligatory for participants to send the following documents via e-mail by the 13th of March, 2016:

- Application form;
- Abstract (thesis of report) in Ukrainian, Russian or English;
- Files must be titled with a surname of the first author in Latin letters:

Surname_application.doc Surname_theses.doc

Both **full-time** and **distance** participation are possible.

The publication of materials for authors from abroad whose abstracts will be selected is **FREE OF CHARGE**. In case of attendance of the conference, the participation fee of 20 EUR will apply.

Participants should cover their own expenses with regards to travel, accommodation, and meals. The organizing committee will support the participants in the process of making necessary arrangements for their stay in Chernivtsi.

MATERIALS FORMATTING REQUIREMENTS:

- The volume of the abstract is up to 4 pages of A4. The text must be edited with MS Word (.doc, .docx):
- All margins must be of 20 mm, line spacing is 1,5, Times New Roman 14-points type;
- Figures should be grouped, captions, tables, bibliography should be formatted in Times New Roman 12-points type;
- The first-line indentation must be of 1,25 mm;
- Do not use hyphenation, pages are not numbered;
- Surname and initials are indicated in the right corner in a bold Times New Roman 14-points type.
- Degree, academic title, surname, and initials of supervisor are indicated below;
- Educational establishment is indicated below in italics;
- Title of the article is in the middle of the page in bold, 14-points type;
- Summary of the theses should be written in English up to 4 lines or up to 350 symbols in italics, 12-points type, with line spacing 1 and justified alignment;
- List of references is given at the end of the theses. In case of reference in the text number of position in the list of references and page should be indicated in square brackets [1, p. 111]. Footnotes at the bottom of the page are not allowed.

Materials must be thoroughly checked in accordance with the norms of grammar and orthography. The authors and scientific supervisors are responsible for contents of materials.

The Organizing Committee reserves the right to edit or reject an author's text publication.

Conference materials will be published in a collection of theses before the beginning of the conference and will be distributed to the participants during a month after it.

Abstracts (materials) that do not correspond to the above-mentioned requirements and that are submitted without the electronic version or are received after the deadline will not be considered.
